Itinerary:

DAY 01 MANILA / NEW YORK

Assemble at the airport for your departure flight to New York. Upon arrival at New York International Airport. Meet and transfer to hotel for check in. Overnight at **Sheraton JFK Airport Hotel** or similar class.

DAY 02 NEW YORK / PHILADELPHIA / WASHINGTON D.C

(B/L/D)

After breakfast, depart for Philadelphia. Upon arrival, begin sightseeing tour with visit to **Liberty Bell**, site of the Independence Hall and walk around America's most historical square the site where the U.S Constitution was drafted. Lunch at local restaurant. After lunch, continue to Washington D.C. Dinner at local Restaurant. Overnight stay at **Renaissance Washington Downtown Hotel** or similar class.

DAY 03 WASHINGTON D.C

(B/L/D)

After breakfast, we will begin with our full day city tour of Washington D.C including visit to the **US Capitol Hills Area** – Seat of the Legislative Branch of the United States, The US Supreme Court – Home of the Judicial branch of government. Library of Congress – The World's largest Library with 26 million books, films, documents and photographs. Visit **Ford's Theatre, F.B.I., Federal Triangle, The Bureau of Printing and Engraving. The Air and Space Museum, Smithsonian Institute, The Washington Monument and the White House.** Lunch will be provided en-route. Continue tour with visit to **The Lincoln Memorial and Jefferson Memorial** – a 19 foot bronze statue of the third President of the United States. Cross the Potomac to Virginia Pass, The Iwo Jima Marine Memorial to the Arlington National Cemetery – A 500 acre site containing the graves of President John F. Kennedy, His wife Jacqueline Kennedy Onassis, forever marked by the vigil of Lone Sentry (eternal flames). Dinner at city restaurant. Overnight at **Renaissance Washington Downtown Hotel** or similar class.

DAY 04 WASHINGTON D.C. / CORNING / NIAGARA FALLS

(B/L/D)

After breakfast, depart for Corning. The city of Corning is the headquarters of Fortune 500 company Corning Incorporated, formerly Corning Glass Works, a manufacturer of glass and ceramic products for industrial, scientific and technical uses. It is also home to the Corning Museum of Glass, which houses one of the world's most comprehensive collections of glass objects from antiquity to the present. After lunch, continue on to **Niagara Falls** – a North American natural wonder and one of the Nature's most exciting creations. Millions of gallons of water rocket over Niagara Falls every minute – about 750,000 gallons each second !! Dinner at local restaurant. Overnight stay at **Sheraton Hotel** or similar class.

DAY 05 NIAGARA FALLS

(B/L/D)

After breakfast, we will begin with our full day tour of Niagara Fall including winery tour in Niagara on the lakes. The fertile soil and adequate rainfall of the Niagara region contribute to the excellent growing conditions on the vineyards. The Niagara USA region has a unique microclimate for the production of world class wines, along with a beautiful countryside situated on the Niagara Escarpment, which was created by erosion. Tour also including **Maid of the Mist or Cave of the Winds** (depending on seasonality). Niagara Falls attracts some 12 million tourists to her majestic awesome beauty each year and is the second largest falls on the globe next to Victoria Falls in Southern Africa. Lunch and dinner will be provided at local restaurant. Overnight stay at **Sheraton Hotel** or similar class.

DAY 06 NIAGARA FALLS / BOSTON

Breakfast at the hotel. Morning driving across the **Upstate New York to Boston**, the largest city in New England, the capital of the state of Massachusetts, and one of the most historic, wealthy and influential cities in the United States of America.
