

# NETHERLAND VISA REQUIREMENTS:



## APPOINTMENT PROCEDURE:

- Set an appointment online thru their website : [www.vfsglobal.com/netherlands/philippines](http://www.vfsglobal.com/netherlands/philippines)
- Click "Schedule an Appointment"
- Choose "Netherlands Embassy Philippines" for Visa Application Centre application submission location.

## GENERAL REQUIREMENTS FOR ALL VISA APPLICANTS:

### TOURIST VISA:

- Duly filled out and signed Schengen visa application form (original and photocopy).
- Two (2) recently taken passport-sized photo (not used in previous visas and teeth not showing).
- Current passport with at least 2 blank pages/ at least 3 months valid upon return.
- Previous passports
- **Proof of travel:**
  - Copy of the roundtrip airline reservation with Passenger Registration Number (or reservation number) and travel itinerary.
  - Airline itinerary should cover your entry and exit to and from The Netherlands and to all Schengen countries of destinations.
  - The reservation should prove that the stay in the Schengen area does not exceed 90 days. It is recommended not to buy the ticket until the visa is granted.
- Proof of Travel medical insurance coverage (Eur 30.000)
  - The insurance must cover the entire period of intended stay, valid for all Schengen States and covering any expenses which may arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during the stay.
- **Proof of accommodation:**
  - Hotel confirmation or hotel voucher (to all Schengen states of destination)
  - If you are joining a cruise, please provide your reservation certificate and the ship's itinerary.
  - Any other land or tour arrangements and tour itinerary.
- **Proof of financial means of the applicant.** One or more of the following documents may be submitted:
  - Bank certification, bank books.
  - Recent personal bank statement or balance over the last three months.
- **Proof of occupation If employed:**
  - Certificate of employment
  - Certificate of leave of absence
- **If self-employed:**
  - DTI/SEC registration of business
- **Mayor's permit If student:**
  - Proof of enrollment
  - Certificate of leave of absence if traveling during the school year and School Calendar.
- **If minor traveling either of the parents:**
  - Notarized affidavit of support & consent of parents/legal guardian
  - Photocopy of passport of parents/legal guardian
  - Proof of economic means of parents/legal guardian (Bank Statement)
  - Birth certificate of the minor
  - DSWD clearance (if traveling without both parents)





- If traveling with spouse and/or children :
  - Marriage contract
  - Birth certificates of children
- For spouse of EU nationals travelling with or meeting the EU citizen:
  - Proof of marriage: marriage contract, marriage certificate.
  - Photocopy of the EU national's passport.
- For non-Filipino applicants who have valid residence status in the Philippines:
  - Copy of Alien
  - Certificate Registration (ACR).
  - Re-entry permit.
- Photocopies of all originals including your passport bio data page. The embassy will return originals to you and keep the copies. Only for some documents the Embassy needs the original and you can keep a copy for your reference.

**Please enclose all the above documents in 1 long brown envelope.**

**Please do not write anything on the envelope.**

### **VISA PROCESSING FEE:**

**PHP 6,500.00 (Price are subject to change without prior notice)**

**VISA PROCESSING TIME:** 15 to 20 working days.

**NOTE:** Other documents may be required by the Embassy of the Kingdom of The Netherlands.

### **IMPORTANT REMINDERS:**

- Please submit complete documents to avoid delays in processing.
- Please do not leave any blank in the application form. Kindly put "N.A." if it's not applicable.
- Make sure that the back page of the passport is completely filled-up (address, tel numbers and name of person to be contacted in case of emergency).
