	Valid Passport (For applicants aged 12 years old and above, the passport must be signed by the holder or by a parent.) Note: It is preferable that the mother signs on behalf of the minor.

	Income Tax Return (ITR) or BIR Form 2316	
	Certificate of employment (stating position, date hired, salary, telephone, issue date and address)	
	For Businessmen: Photocopy of DTI, SEC or GIS and Business or Mayor's permit	
	For first timer: Original Latest PSA Birth certificate, issued within one (1) year. Incase of no record or non readable, submit certificate of no record together with the one issued by the Local civil registrar **No need if with previous USED Japan visa**	
	For first timer: Original Latest Marriage Certificate , issued within one (1) year. Incase of no record, submit certificate of no record together with the one issued by the Local civil registrar ***No need if with previous USED Japan visa**	
	Affidavit of Support (Notarized)	ICARD/PRC ID (Photocopy, front and back)
	Guarantee Letter (Computerized)	Daily schedule or Itinerary (Computerized)
	For senior/retired: Senior ID or Letter	If Student: School ID or School Certificate
	Two (2) Signed Authorization Letter	
	If late registered: submit Original Baptismal and original form 137. If cannot comply, application must prepare a valid explanation letter with original signature (they do not accept e-signature)	
	Signed Waiver Form (to confirm that they understand and accept the terms, conditions, or responsibilities related to their visa application (e.g., travel risks, processing delays, or non-refundable fees).
